<b>Investment objective:</b> The Sub-Fund aims to achieve a long-term return in excess of Standard & Poor's (S&P) 500 Index (Total Return Net) (the "Benchmark") by actively investing primarily in a portfolio of US companies.		
<b>Investment policy:</b> The Sub-Fund pursues an actively-managed investment strategy.		
<b>Investment approach</b>

<b>Investor profile:</b> Typical investors in the Sub-Fund are expected to be investors who want to take broad market exposure to the US stock market, who seek to benefit from potential excess returns with similar risks to investing in securities representing the Benchmark and who are prepared to accept the risks associated with an investment of this type, including the volatility of such market.

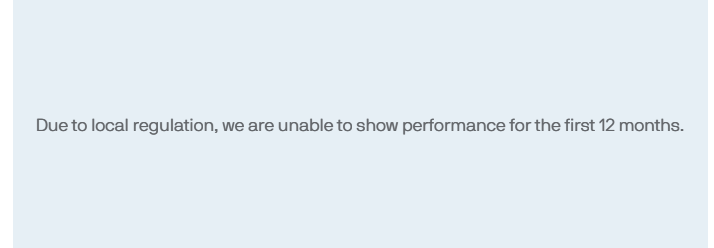

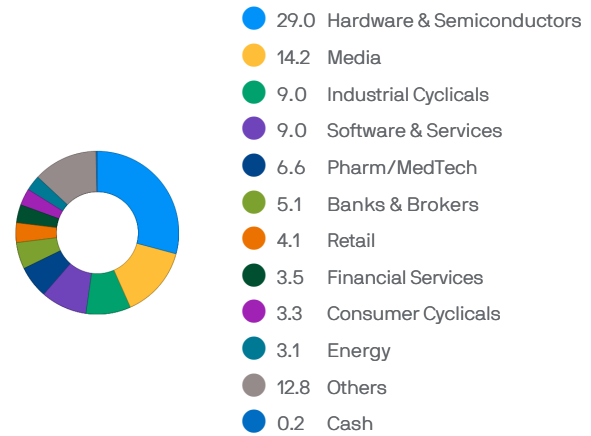
