**FUND OVERVIEW**

The fund aims to achieve a return on your investment, through a combination of capital growth and income on the Fund's assets, which reflects the return of the Bloomberg Global Aggregate Corporate - United States Dollar Index, the Fund's benchmark index ("Index").

**KEY BENEFITS**

1. Exposure to US Dollar denominated investment grade bonds within the corporate sector of the Bloomberg Global Aggregate Index ("Parent Index").
2. The bonds within the fund must: (i) have a minimum par amount outstanding of USD 300 million; (ii) have at least one year until maturity; and (iii) be rated investment grade (Baa3/BBB-/BBB- or higher) using the middle rating of Moody's, S&P and Fitch.
3. This Fund is suitable for medium to long term investment, though the Fund may also be suitable for shorter term exposure to the Index.

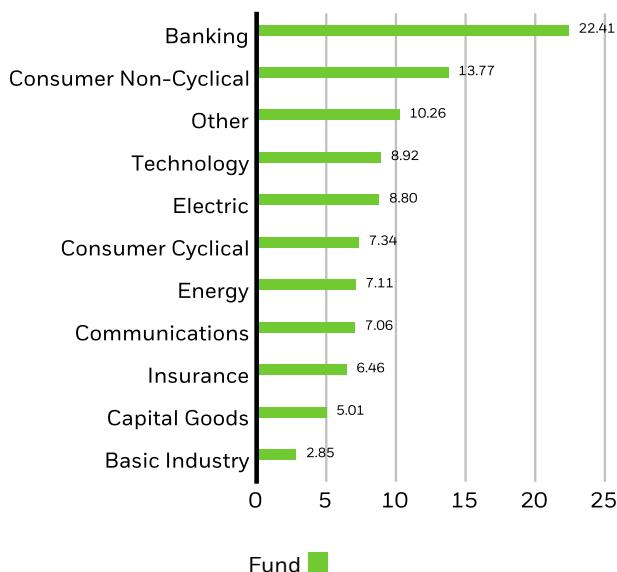

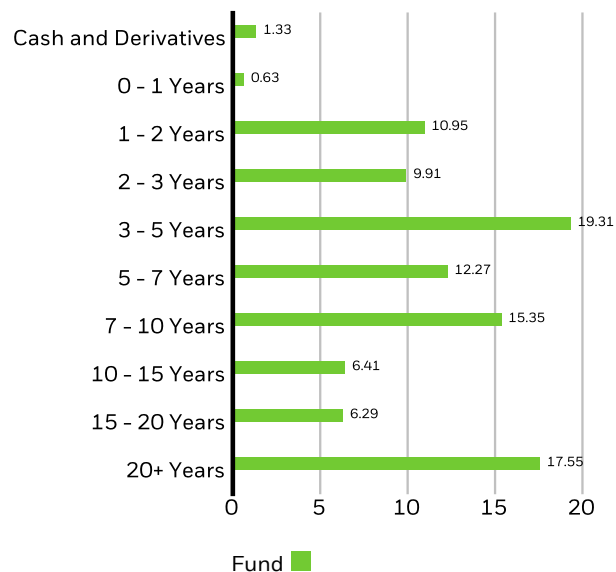

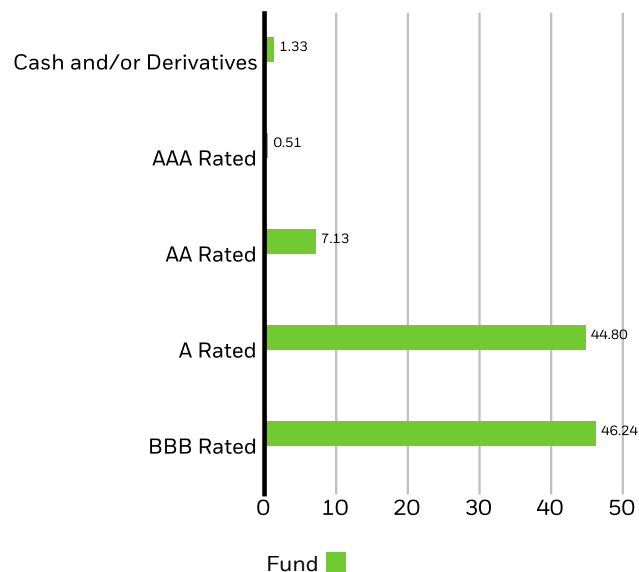

#### GLOSSARY

For callable bonds, YTM is the Yield-to-Worst.

**Effective Duration:** Effective duration is a measure of a fund's interest-rate sensitivity. Put simply, the longer a fund's duration, the more sensitive the fund is to shifts in interest rates. So a fund with a duration of 10 years is twice as volatile as a fund with a five-year duration.
