High Growth Potential

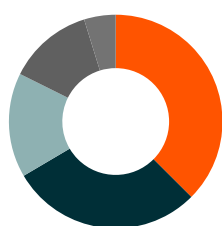

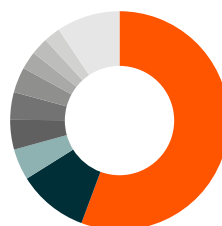
