Investment / Performance Objectives & policy

The fund mainly invests in US government bonds denominated in US dollar. The fund generally favours direct investment but may at times invest through derivatives. Specifically, the fund normally invests at least 90% of total net assets in debt and debt-related instruments, including money market instruments, issued by issuers that are included in the benchmark. The credit rating and duration of securities are usually consistent with those of the benchmark. The fund may also invest in securities that are not constituents of the benchmark where such securities offer a risk and return profile that is similar to that of some constituents of the benchmark. The exposure to the benchmark is mainly achieved through physical replication. The fund may invest in the following asset classes up to the percentages of total net assets indicated:

- corporate bonds: 10%
- deposits in any currency: 10%
- units of UCITS and other UCIs: 10%

Tracking error Maximum, 0.50% (in normal market conditions)

The fund may use derivatives for reducing risks (hedging) and costs, and to gain additional investment exposure.

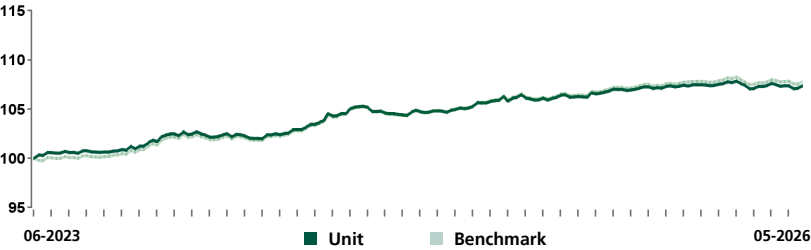

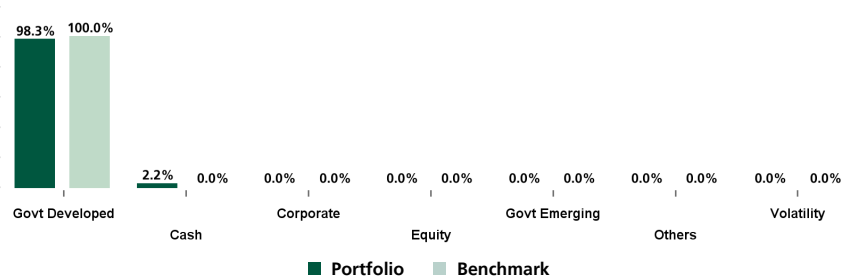

Asset Breakdown*



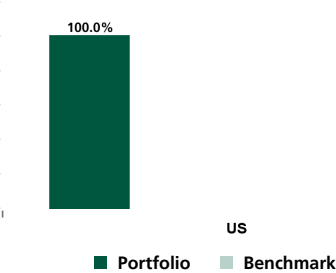

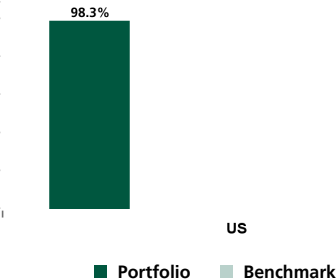

Investment Manager Commentary

Performance and Investment Choices

In May the performance of the US short-term bond market was positive by 0.14% in local currency.

During the month, no Federal Reserve meeting took place.

On the macroeconomic side, CPI YoY for April came in at 3.8%, above the 3.7% consensus, while CPI MoM matched expectations at 0.6%; PPI Final Demand MoM surprised sharply to the upside at 1.4% versus a 0.5% survey. Employment data showed April Nonfarm Payrolls at 115k, beating the 65k estimate, with the Unemployment Rate stable at 4.3% as expected; ADP Employment Change came in below consensus at 109k versus 120k. GDP Annualized QoQ for Q1 (second estimate) was revised down to 1.6% from the advance reading of 2.0%. On the manufacturing side, the S&P Global US Manufacturing PMI for May (preliminary) beat at 55.3 versus 53.8, while ISM Manufacturing for April came in at 52.7, slightly below the 53.2 survey.

Over the month the short-end Treasury curve shifted upward: the 2yrs and 3yrs yields increased by 11 bps and 13 bps respectively. The 2yrs benchmark bond closed the month at a level of 4.01%. As far as the EUR/USD exchange rate is concerned, USD appreciated by 0.51% relative to the EUR.

Fund performance was in line with the one posted by its benchmark. Over the month, the fund implemented a marginally long duration position relative to the benchmark.
