Valour Bitcoin (BTC) Zero SEK is an investment product which precisely tracks the price of BTC without charging management fees, making investment in the world's best-known digital asset easier, more secure and more cost-effective than all other options. The product is a structured investment in the form of a tracker certificate under Swedish law and traded on the Nordic Growth Market (NGM) Exchange as the primary marketplace.

## CALCULATING THE PRICE OF VALOUR BITCOIN ZERO Leverage



We calculate the arithmetic mean price from four major exchanges<sup>1</sup>.



Using market rates, we convert the dollar value of BTC (BTC/USD) into the product currency (SEK).



We apply the multiplier 0.0001 to set the price of one certificate, making it an affordable unit price
