INTRODUCTION

Valour Ethereum (ETH) Zero SEK is an investment product which precisely tracks the price of ETH without charging management fees, making investment in the world's second largest digital asset easier, more secure and more cost-effective than all other options. The product is a structured investment in the form of a tracker certificate under Swedish law and traded on the Nordic Growth Market (NGM) Exchange as the primary marketplace.

CALCULATING THE PRICE OF ETHEREUM ZERO



We calculate the arithmetic mean price from four major exchanges¹.



Using market rates, we convert the dollar value of ETH (ETH/USD) into the product currency (SEK).



We apply the multiplier 0.001 to set the price of one certificate, making it an affordable unit price
