## FUND AIM

The Fund aims to provide investors a return in line with the performance of the global corporate bond market, as represented by the J.P. Morgan Global Credit Index (GCI) ESG Investment Grade Custom Maturity Index (the "Index").

## WHO IS THIS FUND FOR?

- This fund is designed for investors looking for growth and income from an investment in bonds issued by corporations in developed markets
- Although investors can take their money out at any time, this fund may not be appropriate for those who plan to withdraw their money within five years
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment
- If you do not understand this document we recommend you seek additional information to help you decide if this fund is right for you

## FUND SNAPSHOT

- **What does it invest in?** Invests predominately in US Dollar, Euro and Sterling denominated investment grade corporate bonds, issued by developed market issuers.
- **How does it invest?** Passively managed, aiming to replicate the performance of the Index
- **Does it promote sustainability characteristics?** The Fund promotes a range of environmental and social characteristics. Further information on how such characteristics are met by the Fund can be found in the Supplement.
- The Fund will invest more in companies with higher ESG scores, and will also invest in companies with lower ESG scores, but by a reduced amount.

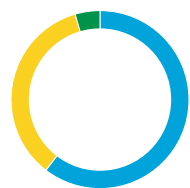

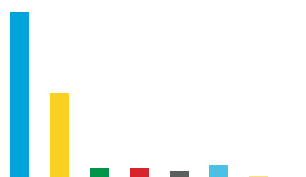
## PORTFOLIO BREAKDOWN

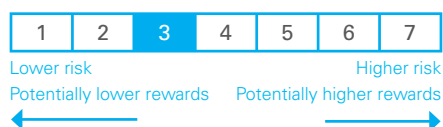

The Index Fund Management team comprises 30 fund managers with an average experience of 15 years, supported by 33 broader team members. Management oversight is provided by Howie Li, Global Head of Index Funds. The team also has full access to the resources and research of other specialists within L&G, including economists and strategists.

## RISK AND REWARD PROFILE

## KEY RISKS

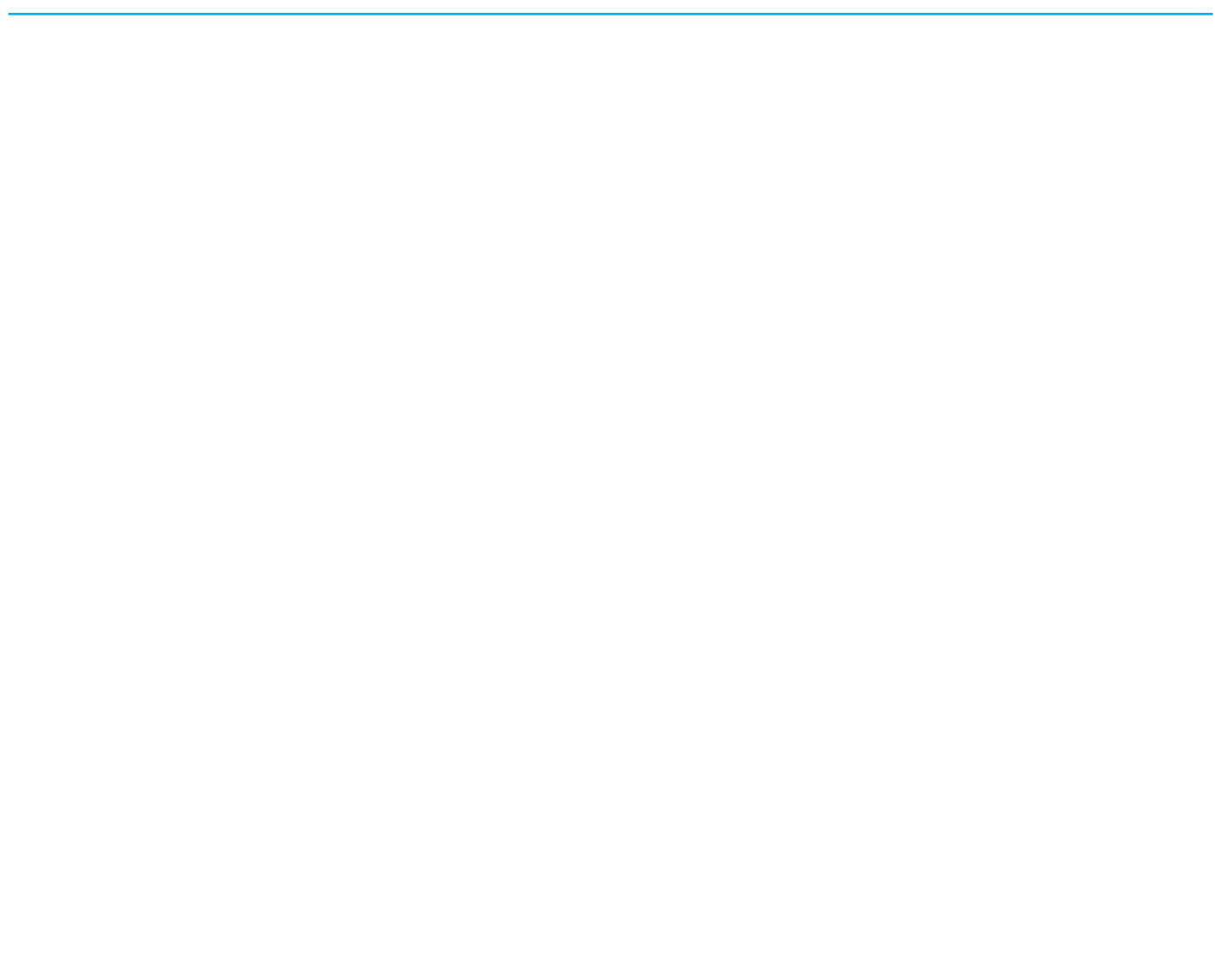
