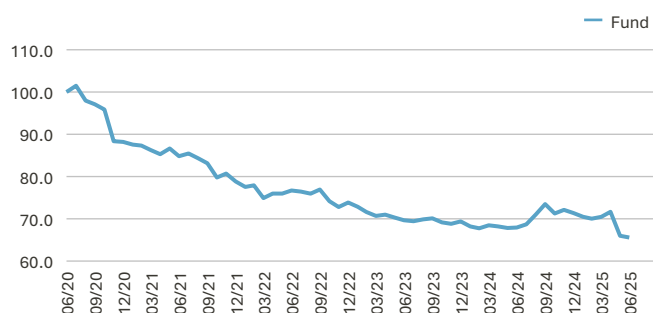
LGT Dynamic Protection UCITS Sub-Fund Class H (CHF) returned -0.62%. The S&P 500 continued its strong run from May and climbed 5% in June to close out the month at a new record high, eclipsing its previous mid-February peak in a stellar rebound from a near-bear market sparked by President Trump's barrage of global tariffs two months ago. After the cease-fire between Israel and Iran, the VIX receded by month-end to levels implying some complacency in markets. Likewise, intra-month spikes in crude oil and gold prices reverted. Conversely, the US Dollar continued its slide while Treasury yields only declined a little as US trade and economic policies triggered worries over vast borrowing needs and bets on lower interest rates. Against the backdrop of an ebullient equity market, the fund managed to preserve capital with the DyanMEQ equity overlay as the best contributor. Conversely, FX Hedge was challenged by the weakening US dollar and Commodity Hedge detracted due to whipsawing losses in energy markets. Overall, risk taking was at medium levels, mainly from FX, rates and government bonds.

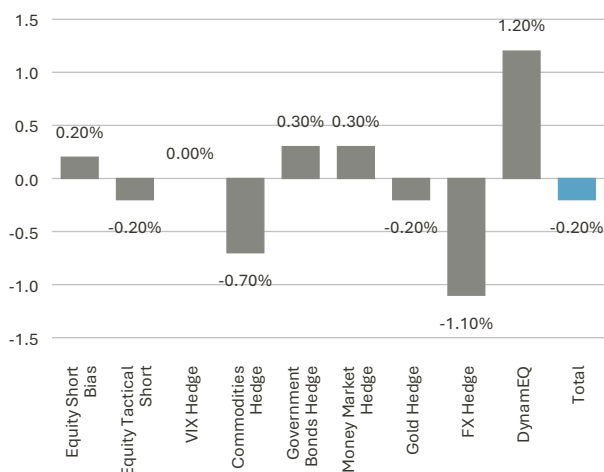

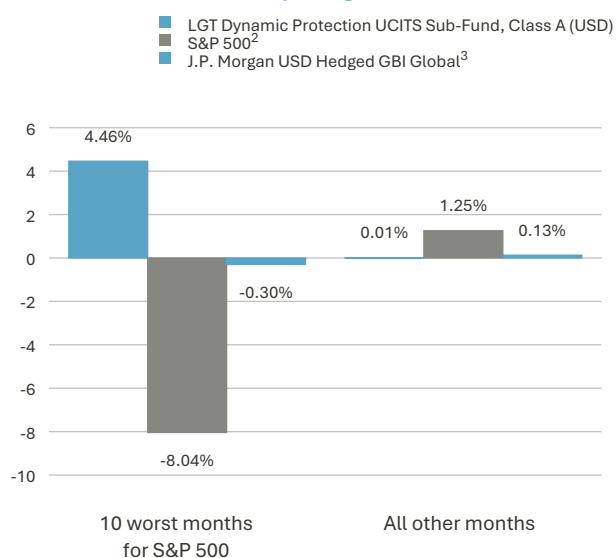
Performance contribution in USD – June 2025, gross of fees

LGT Dynamic Protection is a cost-effective crisis risk offset strategy aiming to reduce the severity of tail-risk outcomes by delivering a return stream that is strongly negatively correlated to equity markets but does not entail a long-term performance drag. The strategy employs a fully systematic approach that invests dynamically in deep and liquid markets, mainly standardized financial futures contracts linked to implied volatility, equity indices, gold, commodities, sovereign bonds, interest rates and foreign currencies, traded electronically in large amounts on major global exchanges.
