FUND OBJECTIVE

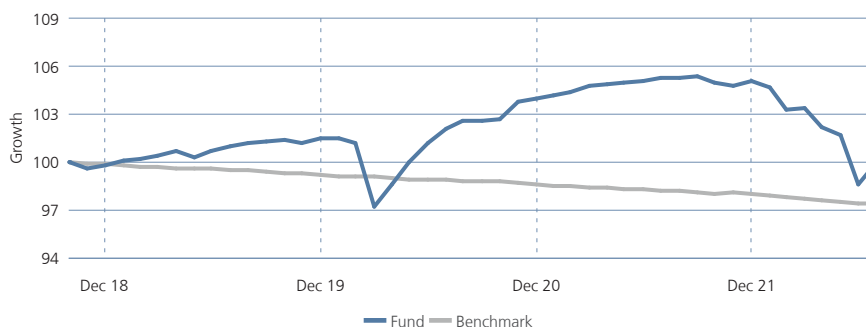
