

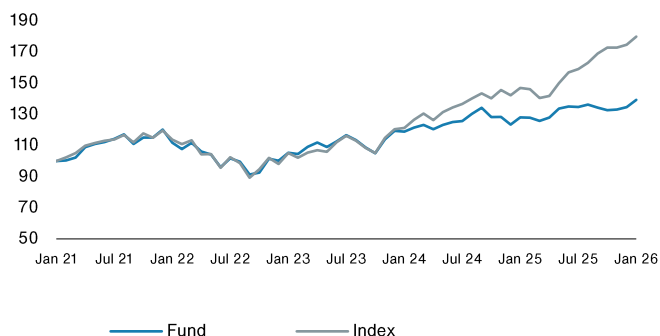
Investment proposition

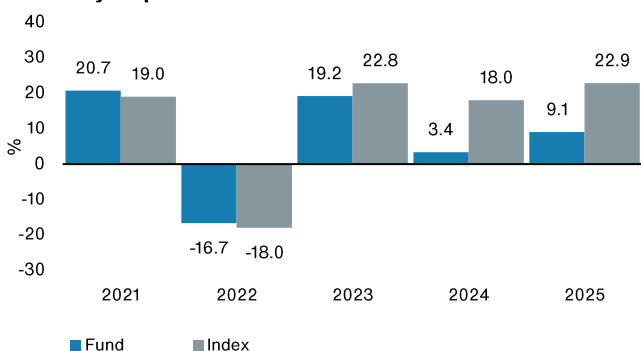
Indexed to 31 January 2026

Its Investment Manager and Distributor is Baillie Gifford Investment Management (Europe) Limited ("BGE").
