# What is the product?

**Type:** This Product is a share in a Sub-fund of the Umbrella qualifying as an alternative investment fund under the law of 12 July 2013 on alternative investment fund managers and the AIFMD regulation.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.


**Objectives:** The Sub-fund is actively managed aiming to achieve regular income and preserve capital. In order to achieve such aim, the Sub-fund invests directly in securities such as money market instruments, fixed-rate bonds, floating rate notes and inflation-linked debt securities that are issued by first-class borrowers or guaranteed by first-class guarantors. The average remaining term to maturity shall not exceed 5 years. The Sub-fund invests worldwide, mainly in USD denominated securities; investments in other currencies are limited to 30% of its net assets. Derivative instruments may be used to hedge currency and interest rate risks. In order to manage credit risk, the Sub-fund may use credit linked notes and credit default swaps. The return of this Sub-fund depends mainly on the price evolution of the underlying instruments as well as the level of leverage used.

**Intended Retail Investor:** This Product is intended for professional and institutional investors, as well as sophisticated retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

# What are the risks and what could I get in return?

#### (A) Summary Risk Indicator





The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets.
