What is this product?

Type

Share of a sub-fund part of an umbrella fund in corporate form.

Term

This product does not have a maturity date, the competent body of the PRIIP (as identified in the offering documentation) is entitled to terminate the product. The amount you would receive in the event of such termination might be lower than the amount you invested.

Objectives

Investment objective The Fund's objective is to generate positive returns, while preserving invested capital, through the market cycle by adopting a flexible management approach.

Investment policy The Fund will be essentially exposed (directly and/or indirectly) to non-Investment Grade corporate bonds denominated in EUR with a maturity date of up to 5 years, including Regulation S securities.

The Fund may also, on an ancillary basis, invest in cash, bank deposits and gain exposure to Money Market Instruments, Investment Grade bonds, non-Investment Grade bonds denominated in hard currencies other than Euro, including from issuers located in Emerging Market countries and/or securities issued pursuant to Rule 144A, debt-related securities (such as eligible debentures, notes and convertible bonds), as well as to bonds with a maturity date higher than 5 years.

The Fund's Net Asset Value can be fully invested in debt and/or debt-related securities having a non-investment grade credit rating.

Indirect exposure may be achieved through the use of financial derivative instruments, including but not limited to, total return swaps, credit default swaps, options and/or via investments in UCITS, UCIs and ETFs.

Investments in asset-backed securities, mortgage-backed securities, non-rated bonds and in distressed/defaulted securities are not allowed. In case

of downgrade, distressed/defaulted securities shall not represent more than 3% of the Fund's Net Asset Value. Investments in contingent convertible bonds are allowed up to 20% of the Fund's Net Asset Value. Investments in equity securities are not allowed. However, the Fund can hold equities up to 20% of its Net Asset Value following the conversion of convertible bonds, including contingent convertible bonds.

Benchmark The Fund is actively managed and references the Performance Fee Benchmark for performance fee's calculation purposes. The Performance Fee Benchmark of the Fund is ICE BofAML Euro High-Yield, Non Fin, BB-B, 1-5Y, Constrained Index (custom index).

Redemption policy The Fund is open-ended. You may redeem shares of the Fund on any Luxembourg business day.

Distribution policy The Share Class makes dividend payment.

Derivatives policy The Fund may use financial instruments and derivatives for hedging purposes, for efficient portfolio management purposes and for investment purposes.

Intended retail investor

The Fund expects that a typical investor in the Sub-fund will be a long term investor who knows and accepts the risks associated with this type of investment. It is designed to form part of a portfolio of investments.

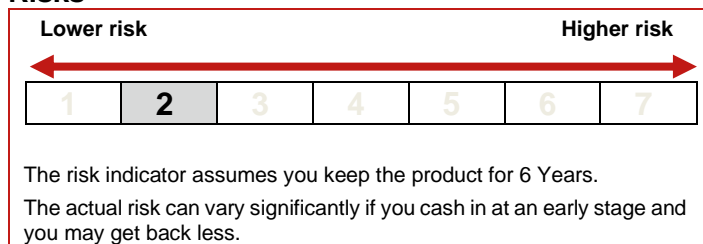

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity to pay you.

Performance scenarios

What happens if Generali Investments Luxembourg S.A. is unable to pay out?

What are the costs?

Costs over time

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- EUR 10 000 is invested.
