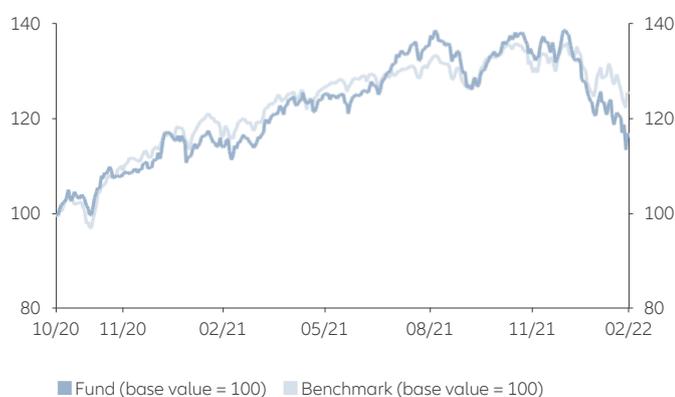

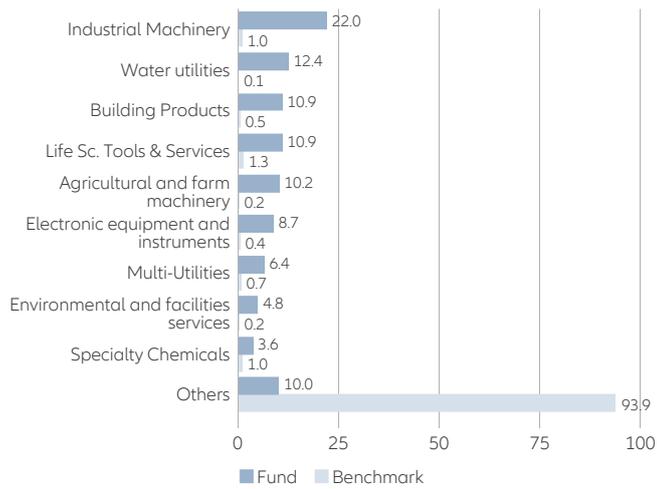

Portfolio Structure ³

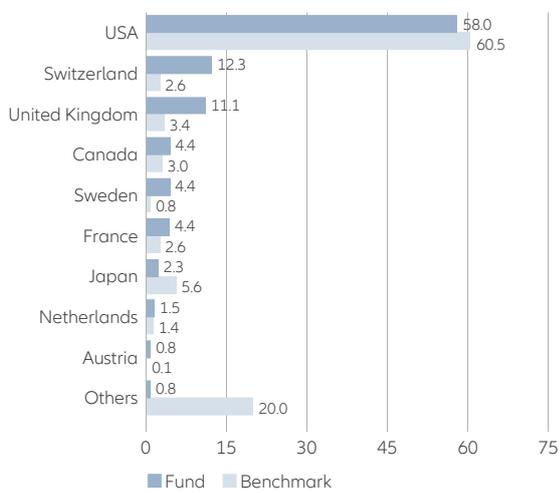
Sector Breakdown (%)
