The objective of the Fund is to provide long term return consisting of a combination of capital growth and income.

The Fund is actively managed and seeks to achieve this objective by investing in a broad range of fixed income securities of which at least 80% will be issued in US Dollar, Sterling or Euro by Developing/Emerging Market governments and comorates.

The Fund will seek to achieve its objective while maintaining a lower weighted average carbon intensity than the Benchmark Index.
