

The overall equity exposure may vary, but is restricted to 60 %. The proportion of securities from emerging markets issuers may not exceed 50 %. The fund's investment objectives are capital growth over the long term as well as positive impacts on the environment and society.




Asset Allocation Breakdown (%)






Equity weighting by sector (%)
