## Fund Description

The Lumyna – MW TOPS Focus (Market Neutral) UCITS Fund seeks to provide investors with consistent absolute returns primarily through investing and trading in equities and equity-related securities of global companies with a methodology that incorporates certain Environmental, Social and Governance (ESG) factors. The Fund aims to generate low correlation to equity indices and targets a volatility range of 4–6%. In seeking to achieve the investment objective of the Fund, the Investment Manager aims to optimise returns while being subject to an ESG framework. The Fund implements a global market neutral strategy employing the proprietary MW TOPS investment process. MW TOPS portfolios are diversified, liquid and dynamic. Structural portfolio diversification allows the Investment Manager to minimise any significant position, industry group, country or factor exposure. The Fund is actively managed, and is not managed in reference to a benchmark.

## Monthly Fund Commentary

The Lumyna – MW TOPS Focus (Market Neutral) UCITS Fund returned 3.02% net (EUR D (acc)) in October, while the MSCI AC World TR Net Local (NDLEACWF) rose 2.79%. Over the month, the net equity market exposure averaged –0.05% while beta-adjusted net equity market exposure averaged 5.59%. The average gross equity market exposure was 298.27%.

Over the month, Semiconductors & Semiconductor Equipment, Technology Hardware & Equipment, and Software & Services were the best performing industry groups. Positions in Telecommunication Services, Utilities, and Pharmaceuticals, Biotechnology & Life Sciences detracted the most from P&L in October. Banks, Semiconductors & Semiconductor Equipment, and Technology Hardware & Equipment were the largest average beta-adjusted long exposures in October. Consumer Services was the largest average beta-adjusted short exposure over the month, followed by Pharmaceuticals, Biotechnology & Life Sciences, and Capital Goods.

Positions in Semiconductors & Semiconductor Equipment contributed the most to the Fund's P&L in October, generating a total positive gross contribution of +124bps; most of the contribution came from long positions in Taiwan, USA, and Japan. The Fund's average beta-adjusted exposure to Semiconductors & Semiconductor Equipment was 5.90% over the month. The index (MSCI ACWI Semiconductors & Semiconductor Equipment, MXWDOSE) rose 12.29% over the month.

In October, positions in Telecommunication Services generated the largest negative gross contribution of –53bps. The Fund's average beta-adjusted exposure to this industry group was –0.99% over the month. In this industry group, short positions in Japan, and long positions in USA and Saudi Arabia contributed the most to the negative return. The index (MSCI ACWI Telecommunication Services Industry, MXVWDOTS) fell –0.67% over the month.

The Lumyna – MW TOPS Focus (Market Neutral) UCITS Fund remains highly diversified and liquid, with 687 positions greater than ±0.05% of NME (883 positions in total) on average over the month and with over 99% of investments able to be liquidated in a single day (calculation based on trading a third of the 30-day average volume).

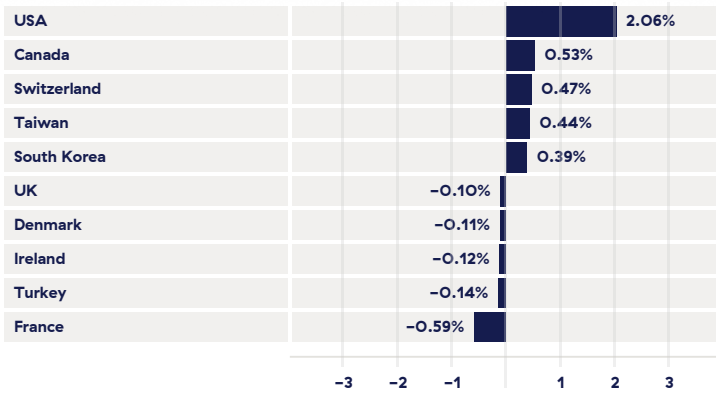

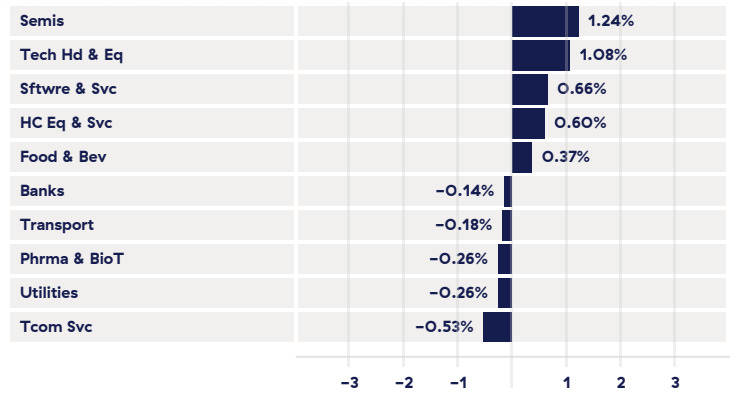

Country Equity P&L as % of NAV - Top 5/Bottom 5



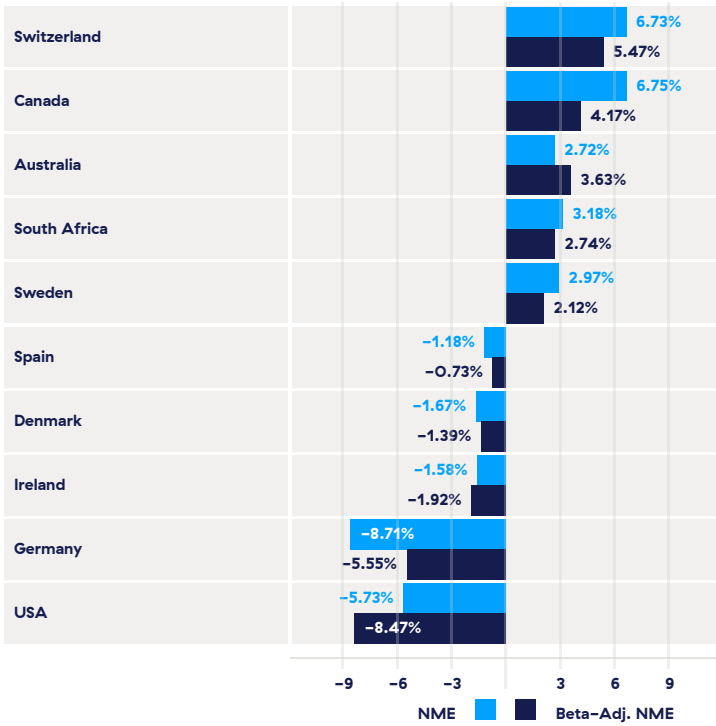

Industry Group Equity P&L as % of NAV - Top 5/Bottom 5



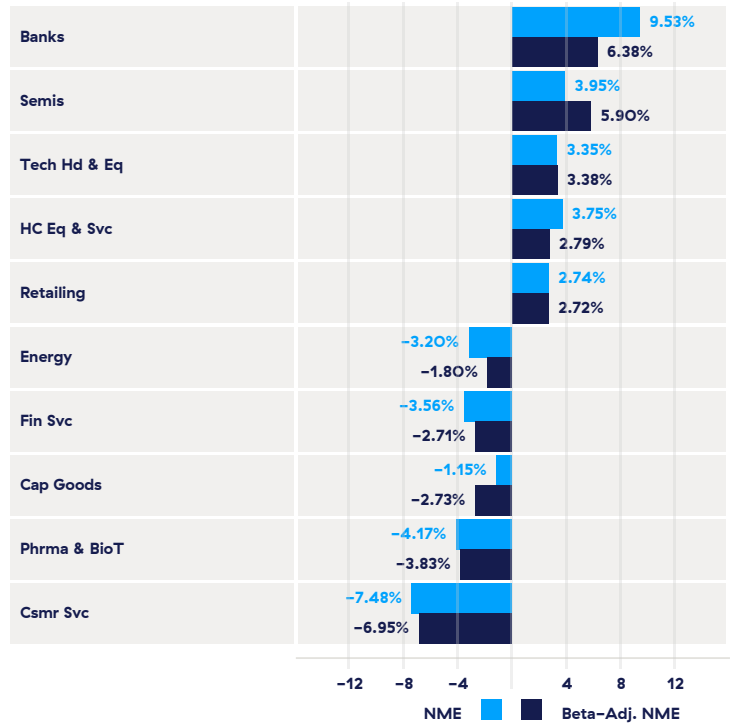

Avg. Country Beta Adj. Equity Net Exposure as % of NAV - Top/Bottom 5



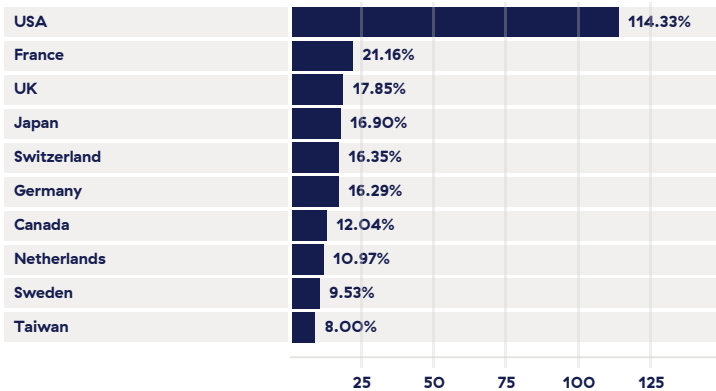

Avg. Industry Group Beta Adj. Equity Net Exposure as % of NAV - Top/Bottom 5



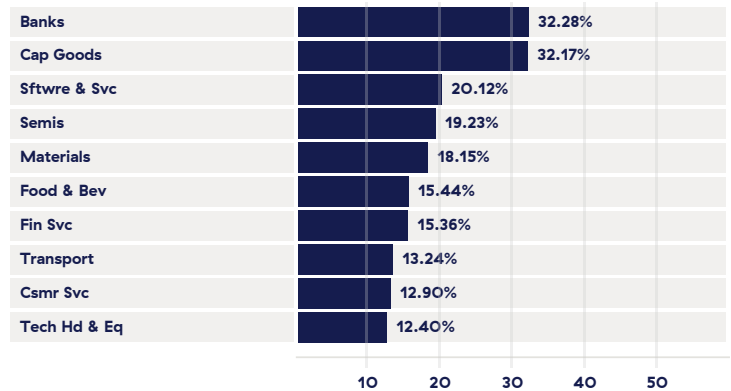

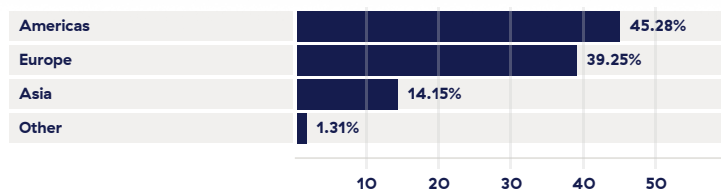
Avg. Industry Group Equity Gross Exposure as % of NAV - Top 10

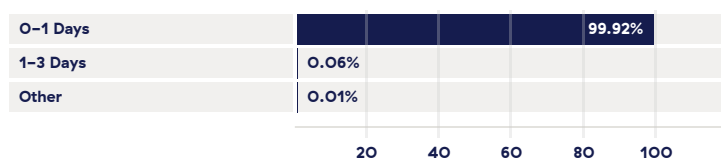
### Avg. Regional Equity Gross Exposure as % of Total NAV

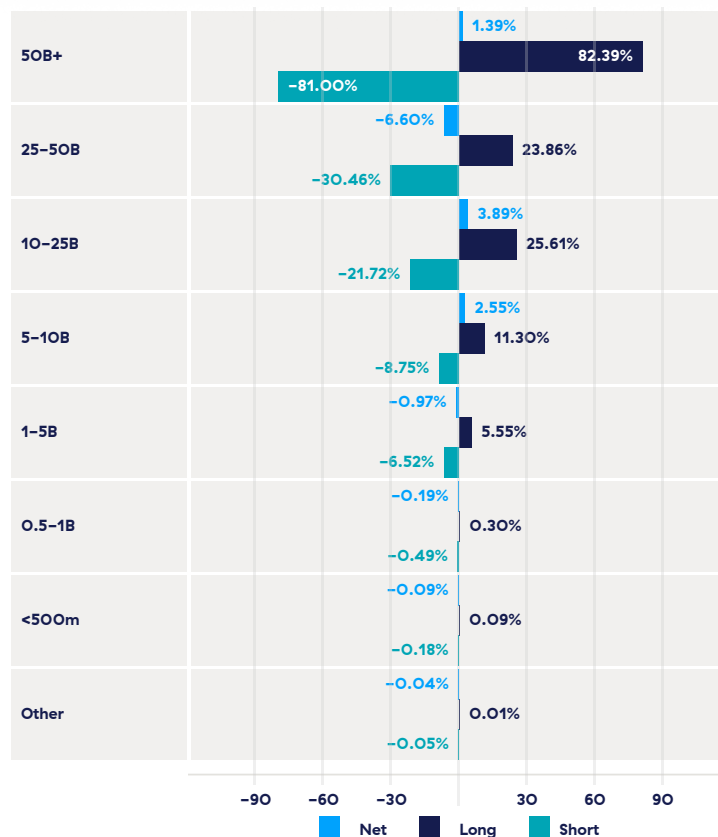
