## FUND AIM

The objective of the Fund is to provide long term return consisting of a combination of capital growth and income.

The Fund is actively managed and seeks to achieve this objective by investing in a broad range of bonds and bond related instruments denominated in Euro, GBP and USD, with at least 70% to be invested in a portfolio of Euro denominated bonds, and 70% of the fund to be invested in corporate bonds.

The Fund aims to deliver this objective while maintaining a lower weighted average carbon intensity than the broader European investment grade credit universe.

## WHO IS THIS FUND FOR?

- This Fund is designed for investors looking for income or growth from an investment in fixed income securities
- Although investors can take their money out at any time, this fund may not be appropriate for those who plan to withdraw their money within five years
- This fund is not designed for investors who cannot afford more than a minimal loss of their investment

## FUND SNAPSHOT

- **What does it invest in?** Invests in a broad range of bonds and bond-related instruments denominated in Euro, Sterling and US Dollar, with at least 70% invested in a portfolio of Euro denominated bonds. Invests at least 70% in corporate bonds. Investments are restricted to be in line with the ESG criteria described in fund sustainability characteristics.
- **How does it invest?** Actively managed, investing primarily in fixed income securities with an investment grade (lower risk) credit rating. The fund targets a lower weighted average carbon intensity (WACI) than the broader corporate index through investing in companies with low carbon footprints and by using LGIM's proprietary Destination@Risk framework. The fund leverages MSCI, a leading provider in ESG data, to highlight laggard companies and controversies whilst combining this with LGIM's proprietary ESG expertise to support an enhanced exclusion framework as described in the fund's Supplement. The Fund adheres to the exclusionary criteria for the "Paris-aligned Benchmark" (PAB) standards
- **Does it promote sustainability characteristics?** The Fund promotes a range of environmental and social characteristics. In particular, the Fund applies product and business involvement exclusions and minimum standards relating to climate, controversies, ESG ratings and factor evaluation. Further information on how such characteristics are met by the Fund can be found in the Supplement.

As the swinging price only affects shareholders which place subscription or redemption instructions, we have used the notional unswung mid-price history in the tables and charts above in order to remove the volatile effect that the swing pricing has on the depiction of past performance of the Fund.

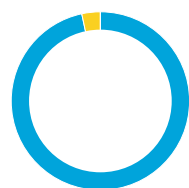

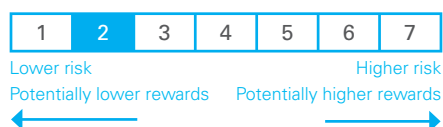

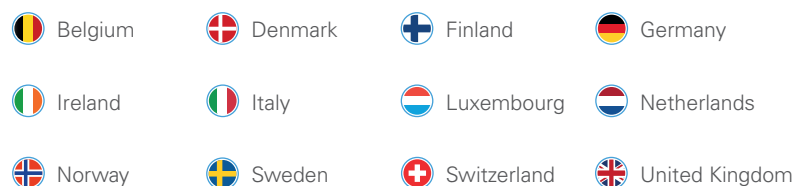


## KEY RISKS
